## **COOKIE POLICY**

(In compliance with art. 9 of Law 13.709/19 – LGPD [General Data Protection Law])

#### 1. Introduction.

This Cookie Policy of Carvalho, Sica, Muszkat, Vidigal e Carneiro Sociedade de Advogados ("CSMV" or "Firm") website, located at the electronic address www.csmv.com.br ("Website"), is complementary to the CSMV Advogados Privacy and Data Protection Policy available at [link].

#### 2. What are Cookies and what is their use?

The term "cookies" means small text files or pieces of information that are downloaded onto your device for a short period of time and used to monitor a user's internet access when such user visits any website ("Cookies").

By accepting Cookies, users are not transferring any type of virus or malware to their devices, since Cookies consist merely of records of the activities and unidentified preferences of users browsing a given website, being updated every time there are new accesses by users.

Cookies are therefore sent simultaneously with your browsing of our Website. Thus, Cookies are thus sent to your device and are stored in a folder located within your internet browser, allowing our Website to retrieve some unidentified internet browsing information on a next access, such as preferred language, region of access and others.

As for their importance, Cookies are relevant because through them, user access metrics and analysis of their behavior when accessing our Website are generated, in order to allow monitoring and improvement of the performance and functioning of the Website, and also so that we can offer you a better browsing experience, "remembering" your preferences in further accesses.

Cookies can also be used to authenticate users and prevent fraud, to the extent that the data obtained through Cookies can be cross-checked with the data provided by the user within a registration process carried out on our Website.

For example, through the use of Cookies, CSMV is able to map how users arrive at our Website (whether through social networks or internet search engines), which are the most and least visited pages within our Website, and in which geographical regions our user bases are located.

## 3. Types of Cookies Used.

Cookies can be classified as follows:

Session Cookies. These are temporary cookies used to record your preferences only during your visit to the website. Such Cookies are not stored on the hard disk (they are stored in the RAM memory) being automatically deleted when the browser is closed.

<u>Persistent Cookies</u>. Used to record your browsing preferences and will remain on your device even if your browser is closed or even after a reboot of your device. These Cookies are used to monitor user behavior patterns and their main functions are user authentication and browsing tracking.

For the performance of some functions within our Website, such as the registration of resumes, for example, or even for the insertion of links to our posts on social networks, it is possible that we use third-party suppliers.
