

WEBSITE TERMS OF USE **CARVALHO, SICA, MUSZKAT, VIDIGAL E CARNEIRO SOCIEDADE DE ADVOGADOS**

These terms of use of the website ("[Terms of Use](#)") aim to establish the guidelines regarding the use of the website "www.csmv.com.br" ("[Website](#)") by all those who access it ("[User](#)" or "[Users](#)").

By browsing the Website, Users express their agreement to the conditions set out in these Terms of Use. The use of the Website is also conditioned upon acceptance of other terms and policies associated with the Website, such as the Privacy Policy Data Protection Policy and Cookies Policy, which are incorporated herein by reference. Therefore, Users should carefully read these terms and policies, make sure they have understood them, be aware of all the conditions set out in these Terms of Use and undertake to comply with them.

If you do not agree with the conditions below or any of the conditions set out in our Privacy and Data Protection Policy, available at [\[insert link\]](#) ("[Privacy Policy](#)") and our Cookies Policy, available at [\[insert link\]](#) ("[Cookies Policy](#)"), the User shall immediately terminate his/her use of the Website.

These Terms of Use, along with the Privacy Policy and the Cookies Policy, constitute an entire and binding agreement between the User and Carvalho, Sica, Muszkat, Vidigal e Carneiro Sociedade de Advogados ("[CSMV](#)" or "[Office](#)"), a law firm registered with the CNPJ/MF under No. 11.367.716/0001-48, with headquarters at Avenida Brigadeiro Faria Lima, nº 1461, Torre Sul, conj. 91/94, Jardim Paulistano, in the City of São Paulo, State of São Paulo, CEP [Zip Code] 01452-002, in relation to the use of the Website.

1. Website Information and Content.

The Website is controlled and operated by CSMV. In this regard, the Website will provide several information related to the Firm's activities and its legal practices, including newsletters and articles written by the Firm's legal staff ("[Content\(s\)](#)").

The Contents are made available only for informational purposes on legal topics, as well as on the Firm and its members, and should not be used or interpreted by the User, under any circumstances, as legal opinions or legal guidelines, nor as part of the lawyer/client relationship, which will only be established through direct contact between customers and CSMV lawyers and through the formalization of a contract for the provision of legal services.

CSMV may, at any time and at its sole discretion, make changes to the Website settings, without the need for prior notice to Users.

2. Website Access

The User is not required to register or provide any personal data to access the information on the Website.

If the User chooses to contact CSMV through the "contact" tool available on the Website, or through any electronic address disclosed on the Website or in any of our policies, the User will be solely and exclusively responsible for the accuracy of any information and personal data provided.

Users who intend to register in our database for the purpose of participating in selection processes for vacant positions at CSMV will have their data collected through registration and other communication channels available on the Website and will be forwarded to our administrative department, so that such data can be analyzed by members of the Firm.

In any case of data sharing by the User, such data will be handled in accordance with the Privacy Policy.

3. Restrictions on the Use of the Website by the User

By using the Website, the User undertakes to:

- (i) Not to copy, reproduce, reverse engineer, derive source code, modify, disassemble, decompile or create works based on the Website, in whole or in part;
- (ii) Not to use any information obtained through the use of the Website, which is the exclusive property of CSMV, in order to create products or services that are similar to or replicate, in whole or in part, any of the legal services provided by CSMV;
- (iii) Not to violate, alter or remove, or attempt to violate, alter or remove, any trademark, logo, element protected by intellectual property rights of CSMV related to the Website;
- (iv) Not to copy, reproduce, disseminate or transmit in an automated and/or systematic manner any content available through the Website;
- (v) Not to collect or attempt to collect any data or information from other Users of the Website;
- (vi) Not to violate, or attempt to violate, any security measure employed by CSMV on the Website, or access, or attempt to access, any data, information, network or server managed or used by CSMV whose access does not arise from regular use of the Website;
- (vii) Not to interfere with the Website in any way that exceeds its lawful use, including, without limitation, hacking the Website or server managed or used by CSMV, overloading or attempting to overload the Website, or sending malware or spam to any e-mail address provided by CSMV or through a "Contact" tool available through the Website.

In case of a breach of these Terms of Use, CSMV may, at its sole discretion, block the User's access to the Website, temporarily or permanently, without prejudice to seeking all appropriate legal measures to hold liable for any damage caused to CSMV or any third party as a result of the breach.

4. Intellectual Property.

All the Contents of the Website, including articles, *posts*, databases, trademarks, texts, graphics, icons, designs, colors, layout, services, information, materials, instruments, page organization, drawings and other elements, are protected by intellectual property legislation and are the exclusive property of or licensed to CSMV, and their reproduction and/or use by third parties is prohibited without the prior express written consent of CSMV, and without proper citation of the source, under penalty of the imputation of the applicable legal measures.

5. Third Party Websites and their Contents.

The Website may contain links to third party websites or applications, such as newspaper websites and social media profiles, for the convenience of its Users. Users expressly agree and acknowledge that CSMV is not responsible for the content, goods and services made available on or through these third party websites or applications.

6. Limitation of Liability.

CSMV shall not be held liable under any circumstances to any person for any loss, damage, cost, or expense whatsoever resulting from any inaccuracy, error, omission or change in the information provided on the Website or in these Terms of Use, or for any delays or interruptions related to Content disclosed through the Website.

In addition, CSMV shall in no event be held liable for the quality of the internet connection of Users' devices, the availability or otherwise of internet access services provided by third parties, the inability of using any information or third-party services, which is caused by the incompatibility of the technical configuration of Users' devices, or the breach of privacy or data security of Users while connecting their devices to the

internet through third party services.

CSMV is constantly updating the Website in order to make new Contents available, implement new features or reinforce information security measures, and may, at any time and at its sole discretion, add or remove features, change or adjust the layout of the Website, as well as review, change and/or remove any content previously made available, without this constituting any violation of this Term of Use or generating any right of indemnity to the User.

If CSMV, or any of its partners and/or collaborators, be sued due to the use of the Website by a certain User in violation of these Terms of Use or any applicable law, said User will be fully responsible for such violation, as well as will be held liable for indemnifying the defendant(s) if they are ordered to pay damages due to acts practiced in disagreement with these Terms of Use or any applicable law.

The exclusions and limitations of liability set out in this chapter shall apply to the maximum extent permitted by the applicable law.

7. General Provisions.

No omission, waiver, grant or forbearance by CSMV in connection with the exercise of the rights conferred under these Terms of Use shall constitute a waiver of such rights.

In the event of any provision of these Terms of Use shall be declared void or unenforceable, such invalidity or unenforceability shall not affect any other provisions of these Terms of Use, which shall remain in full force and effect.

These Terms of Use may be updated by CSMV at any time by simply making a new version available on the Website. The updated version of the Terms of Use will become effective after 5 (five) days of its availability on the Website. After this period, if the User continues to access the Website or use its functionalities, the User represents and warrants to have read and agreed with the new version of the Terms of Use.

These Terms of Use are governed by Brazilian law. Any disputes arising from the provisions of these Terms of Use shall be settled before the courts of the Judicial District of São Paulo, State of São Paulo, with express waiver of any other jurisdiction, no matter how privileged it may be or become.
